

## APPLICATION FOR LIFE MEMBERSHIP

Grand Lodge Statute 14.260 provides that Life Membership may be conferred upon **DANIEL A. BLACK, JOHN R. SCHMIDT, LARRY D. LEWIS, THOMAS NASH, and NORRIS RUFF**, who have paid their required annual dues for the period of not less than thirty (30) years preceding their elections.

**DANIEL A. BLACK** was initiated at the Jamestown, New York, Lodge #263 on January 26, 1987; then demitted to Port Orange Lodge #2723 on June 6, 2012; then demitted to Daytona Beach Lodge #1141 on February 10, 2016. He then demitted back to Port Orange Lodge #2723 on August 1, 2017 making him a member in good standing for 33 years.

**JOHN R. SCHMIDT** was initiated at the Daytona Beach Elks Lodge #1141 on August 12, 1979, and was affiliated with the Port Orange Lodge #2723 by transfer demit as member #2948 on August 3, 2010 making him a member in good standing for 40 years.

**LARRY D. LEWIS** was initiated at the Daytona Beach Elks Lodge #1141 on October 31, 1989; then demitted to the Ormond Beach Lodge #2193, and became affiliated with the Port Orange Lodge #2723 on September 2, 2008, making him a member in good standing for 30 years.

**THOMAS NASH** was initiated at the New Smyrna Beach Lodge #1557 March 18, 1988. He then became affiliated with the Port Orange Lodge #2723 on April 9, 2003 making him a member in good standing for 32 years.

**NORRIS RUFF** was initiated on July 27, 1982 at the Pontiac, Illinois Lodge #1019. In the summer of 1987, he demitted to the Joliet, Illinois Lodge #296. On March 27, 2003 he took an Absolute Dimit and lost four years until he became affiliated with the Ormond Beach Lodge #2193 on August 15, 2007. He was a member with Lodge #2193 until May 18, 2016 when he demitted to Port Orange Lodge #2723 on May 18, 2016, making him a member in good standing for 33 years.
